## AGREEMENT FOR ARTISTS' SERVICES

**Sound and Lighting:** Sound and lighting equipment shall be provided by Presenter. Please go to **XXXXXX** to download the most recent tech sheet.

**Recording:** No commercial recording (audio or video) will be made of the performance without the written permission of the Artist. Archival recording is fine, with prior arrangement.

**Insurance:** Presenter warrants that it has both personal injury and property damage liability insurance on the premises at which the performance shall be given.

**Jurisdiction and choice of law:** This agreement shall be governed and construed in accordance with Texas State law. By signing this agreement, the parties recognize the full jurisdiction of Texas courts relative to any dispute arising out of this agreement.

**Force Majeure:** If either party is prevented from performing the obligations created because of illness, an Act of God (defined as fire, flood, accident, riot, order of authority or any other calamity) or if by reason of war, infectious disease outbreak, issues of national security, strikes, lockouts, or any other cause beyond the control of either party, neither party shall be liable for the balance of the contract.

**Additional Provisions...** Presenter will:

Provide hotel accommodations (**XXXXX rooms**) for the band for **XXXXX** nights.

Provide ground transport from/to airport.

Festival food or per diem for food each day.

Provide a green room near stage where artists can warm up before and between shows; and a secure area for musician's instruments.

An area from which to sell recordings, and a person to sell them for the Artist during intermission and at the end of the performance.

All meals plus assorted beverages, or a per diem of \$40. per band member. Bottled water for all on stage. Cold beer for after the performance.

10 Complimentary tickets for the band's use, with prior notice.
